Abstract

State financial management in the Indonesian Air Force environment faces challenges in realizing transparency and accountability. This study aims to evaluate the use of the Agency Level Financial Accounting System Application in improving transparency and accountability of financial management in the Indonesian Air Force. This research method is descriptive qualitative with data collection techniques through in-depth interviews, observations, and documentation studies in various Indonesian Air Force work units that have implemented the Agency Level Financial Accounting System Application. The results of this study are that the implementation of the Agency Level Financial Accounting System Application in the Indonesian Air Force has increased transparency through more systematic recording of financial transactions that are easily accessible to related parties. Accountability has also been increased with the audit trail feature that allows detailed tracking of each financial transaction. The conclusion of this study is that the use of the Agency Level Financial Accounting System Application is effective in realizing transparency and accountability of financial management in the Indonesian Air Force environment, although there are still challenges that need to be overcome.

Indonesia is a large country, stretching from Sabang to Merauke with the fourth largest population in the world. In managing its government, Indonesia requires an integrated system, especially in the management of state finances which are the spearhead that drives all joints of the activities carried out. Current state financial management has been accommodated by the Indonesian Ministry of Finance by implementing the Agency Level Financial Accounting System application. (Ministry of Finance, 2021) A transparent, accountable, effective and efficient financial management system ensures that the government operates well and is responsible for maintaining the integrity of the government, this is no exception including in the management of the defense/military budget which in this case we try to see from the perspective of the Indonesian National

Air Force (TNI AU). Through the development of digital-based applications and integration of government financial management systems, (Pardo, 2008) the Agency Level Financial Accounting System aims to increase transparency and accountability in the management of state finances nationally. The Indonesian Ministry of Finance is developing the Agency Level Financial Accounting System as an information system to combine all processes management of state finances, from planning to reporting. Many modules in this application, including accounting, reporting, budgeting, and treasury, are intended to assist in managing finances better and more efficiently. (Zheng, 2014) The Ministry of Finance has created and in various institutions, including the Indonesian Air Force, as part of bureaucratic reform and modernization of financial administration. (Sivarajah, 2015) Given the complexity and scale of military financial operations, the use of the Agency-Level Financial Accounting System is expected to provide significant benefits in terms of transparency and accountability for the Indonesian Air Force.

Providing transparency in state financial management means providing financial information to interested parties, including the public, auditors, and supervisory institutions, openly and clearly. Good transparency allows for better supervision and prevents corruption or misuse of the budget. On the other hand, the government must be responsible for the use of public funds properly and in accordance with regulations. This is called accountability. With good accountability, all financial transactions can be monitored and accounted for in full, ensuring that state money is used for legitimate and profitable purposes. As part of the Indonesian National Armed Forces, the Indonesian Air Force has an important role in maintaining state sovereignty and protecting national airspace. The Indonesian Air Force requires a large budget and proper financial management to carry out its duties. The Agency-Level Financial Accounting System is expected to improve the Indonesian Air Force's financial management system, which was previously carried out manually and was prone to errors and misuse. The Agency-Level Financial Accounting System facilitates tracking and verification because every financial transaction is recorded electronically and in real time.

In addition, the Agency Level Financial Accounting System offers an audit trail feature, which allows for monitoring every change and transaction in the system. This is very important to ensure that authorities can check and verify every transaction. The audit trail makes it easier to identify budget irregularities and misuse. However, the implementation of the Agency Level Financial Accounting System in the Indonesian Air Force faces several obstacles. Users who are not yet familiar with the new technology show resistance. Everyone working in financial management must be trained and socialized about the System.

3. Technical Constraints: Several technical constraints such as network disruptions and hardware problems were also found during the implementation of the Institutional Financial Accounting System. This can disrupt the financial management process that should run smoothly.

Implementation Strengthening Strategy

To overcome existing challenges and maximize the benefits of the Institutional Level Financial Accounting System, several implementation strengthening strategies are recommended:

1. Training and Socialization. Intensive and continuous training for all personnel involved in financial management in the Indonesian Air Force needs to be carried out. Socialization regarding the benefits and how to use the Agency Level Financial Accounting System is also important to reduce resistance to change.

2. Increasing Human Resources Capacity. Recruitment and development of human resources with skills in information technology and accounting must be improved. Special training programs to improve technical skills also need to be held periodically.

3. Technical Infrastructure Improvement. Investment in improving technical infrastructure such as reliable internet networks and hardware needs to be done. This is to ensure that the Agency Level Financial Accounting System can operate smoothly without significant technical disruptions.

4. Supervision and Evaluation. Strict supervision and periodic evaluation of the implementation of the Financial Accounting System at the Agency Level need to be carried out. This is to ensure that the system runs as expected and to identify and resolve emerging problems quickly.

Analysis

From the results of this study, it can be seen that the use of the Agency Level Financial Accounting System in the Indonesian Air Force has great potential to increase transparency and accountability in state financial management.

With electronic recording, audit trails, and strong internal control systems, the Agency-Level Financial Accounting System is able to make a significant contribution to realizing better financial governance. However, implementation challenges such as resistance to change, limited human resources, and technical constraints need serious attention. The budget, treasury, and reporting management processes become faster and more efficient, facilitating overall financial management. Implementation Challenges; Limited human resources with modern information technology and accounting skills are also challenges that need to be addressed. To overcome this challenge, intensive and continuous training, human resource capacity building, and investment in improving technical infrastructure are needed.

Lastly Implementation Strengthening Strategy; Several implementation strengthening strategies are recommended to maximize the benefits of the Institutional Level Financial Accounting System:

2. Training and Socialization. Intensive and continuous training for all personnel involved in financial management needs to be carried out.
